- CALL TO ORDER:** Board President Dan Conner officially called the meeting to order at 7:00 p.m.
- EXECUTIVE SESSION REPORT:** Jennifer Landon gave the Executive Session Meeting report indicating to the members that the Board of Directors would not meet in Executive Session.
- HOMEOWNER DISCUSSION:** There were no homeowners in attendance to offer comments and ask questions throughout the meeting. Therefore, there was no homeowner discussion.
- COMMITTEE REPORTS:**
- Architectural Committee:** Committee Chairperson Don Morton shared with the Board that there are two (2) open issues pending that require further research. The architectural application for 192 Camino Del Postigo (Francin) has been approved with condition, as the homeowners are required to obtain a building permit from the City in order to proceed with the changes. The architectural application for 3305 Camino Vallareal (Klugg) has been approved and Management has been asked to send an official approval letter to the homeowners.
